Pollard talk on Everest draws crowd at hospital benefit

Thom Pollard of Jackson presented his show "The Path is the Destination" to a sold-out crowd at a recent benefit for Memorial Hospital on Oct. 20.

Pollard, an accomplished photographer, videographer and elite climber, has worked with PBS and National Geographic on several documentaries.

With his Everest tent, Nepalese prayer flags and climbing gear set up on stage at Fryeburg Academy's Leura Hill Eastman Performing Arts Center, Pollard thoughtfully told of his high-risk, lifealtering endeavors on Mount Everest.

Along with his amazing visual photography, it was a rare opportunity for audience members to hear a first-person accounting of the critical dangers and risks of summiting the highest and most dangerous peak on the planet.

What does the White House change to cost-sharing reductions mean

CONWAY — On Friday, Oct. 13, the White House announced that the government would no longer pay health insurance companies to cover the cost of the Cost Sharing Reductions (CSRs). What does this mean for the consumer here in New Hampshire?

First, the policy change will not impact people with health insurance coverage through their employers. This will not impact people covered through Medicaid, Medicare, or the expanded Medicaid program. Consumers who purchase their insurance on Healthcare.gov and who currently receive the Premium Tax Credits to reduce their monthly premium pay-

ment will continue to receive this benefit, and will not see their coverage change or premiums go up due to this.

The CSRs enable consumers who earn too much to receive Medicaid but are still low income to have lower out-of-pockets costs, such as co-pays and deductibles. The difference in the reduction was paid for by the government to their insurance companies.

For example, a consumer who purchases a plan through the Marketplace and does not qualify for a CSR might have a deductible of \$3,500 before the plan covers the health care. Someone who does qualify for a CSR might only have a deductible of \$250 before the health insurance covers the health care.

Insurers are still required by the Affordable Care Act to provide CSRs, but the lost revenue will not be replaced by the government. It is likely that health insurance premiums for those who purchase insurance on the Marketplace but who do not qualify for premium assistance will see much higher rates than in previous years to make up the difference.

In anticipation of this, the three New Hampshire insurance providers, Anthem Blue Cross Blue Shield, Ambetter, and Harvard Pilgrim, all submitted two sets of proposed rates for 2018. One was assuming they would receive the CSR payments from the government, and the other assumed they would not.

After Nov. 1, consumers should log into

their HealthCare.gov account and update their application. White Mountain Community Health Center's navigator, Beth Dyson, is available to assist New Hampshire residents. Appointments are free and take place at the health center, which is just north of Conway Village on Route 16. In 1999, Pollard was the high altitude cameraman for PBS and helped discover the bodies of George Mallory and Sandy Irvine, the first to attempt to climb Everest. Their bodies were found at 27,000 feet, 75 years after their 1924 attempt.

Pollard answered audience questions and was the guest of honor at a reception afterwards.

The Friday night event also unveiled Memorial Hospital's plans to fundraise for, and name, their new Sports Medicine Center which helps promote health and healing to the Mount Washington Valley's athletic community.

The day before Pollard's presentation, he spoke to the student body of Fryeburg Academy and met Nima Sherpa, a junior from Katmandu, the capital of Nepal.

Pollard rigorously encouraged the students to reach for all their want to achieve in life and to always be kind.
